 Provides for the termination of the TOPS-Tech Award beginning with the 2029-2030 award year

Proposed legislation terminates the TOPS-Tech scholarship program with the completion of the 2028-29 award year. Provides for the full repeal of certain statutes pertaining to TOPS-Tech and deletion of references to the program. Students who graduate from high school through the 2026-27 school year will be able to qualify for the award. Any student that enters high school in 2024-25 or after will not be eligible for the award.

EXPENDITURE EXPLANATION

Beginning in FY 28, there will be a decrease in expenditures from a combination of SGF and Dedications out of the TOPS Fund resulting from the termination of the TOPS-Tech program. Based on the last five years of activity, as seen below, the average number of annual TOPS-Tech awards is 2,448 with an average cost of \$6.2 M per academic year.
