CONTROLLED SUBSTANCES RE SEE FISC NOTE GF EX See Note Provides relative to distribution of fentanyl under certain circumstances

<u>Current law</u> makes it unlawful for any person to knowingly or intentionally distribute, dispense, produce, or manufacture a controlled dangerous substance or create, distribute, or possess with intent to distribute, a counterfeit controlled dangerous substance; makes it unlawful for a person to knowingly distribute, dispense, produce or manufacture a controlled dangerous substance in a manner where there is reasonable appeal to a minor due to the shape, color, taste, or design of the fentanyl or the fentanyl's packaging; delineates a list of sentences imposed on those convicted of <u>current law</u>. <u>Proposed law</u> clarifies the application of <u>current law</u> to fentanyl and packaging of fentanyl that reasonably appeals to a minor; adds a sentence of imprisonment for no less than 10 nor more than 40 years at hard labor, without the benefit of probation, parole, or suspension of sentence, for offenders convicted of knowingly or intentionally distributing, dispensing, producing, or manufacturing or creating, distributing, or possessing with intent to distribute, a counterfeit controlled dangerous substance involving fentanyl or fentanyl packaging that is designed to resemble branded or generic prescription medication.

EXPENDITURE EXPLANATION

<u>Proposed law</u> may result in an indeterminable increase in SGF expenditures in the Department of Public Safety and Corrections – Corrections Services (DPS&C – CS) if a person is convicted of knowingly or intentionally distributing, dispensing, producing or manufacturing, or creating, distributing, or possessing with intent to distribute a counterfeit controlled dangerous substance involving fentanyl or fentanyl packaging that is designed to resemble branded or generic prescription medication. <u>Proposed law</u> has the effect of adding a sentence of imprisonment for no less than 10 nor more than 40 years at hard labor, without the benefit of probation, parole, or suspension of sentence, for offenders convicted of its violation. The exact fiscal impact of the passage of this legislation is indeterminable, as it creates a crime, and it is not known how many people will be convicted and subject to a sentence of imprisonment as a result of its potential enactment.

For those convicted, sentenced, and then subsequently housed in a state facility, DPS&C-CS will sustain expenditures of \$107.60 per offender per day, or \$26.39 per offender per day for those housed in local facilities. DPS&C-CS advises that impacts on offender populations are anticipated to impact the number of offenders held in local facilities, and that in managing its offender population, it seeks to fill all beds in state facilities first, then assigns overflow offenders to local facilities. For those convicted, sentenced, and then subsequently housed in a local facility, DPS&C-CS will sustain expenditures of \$26.39 per offender per day.

REVENUE EXPLANATION

<u>Proposed law</u> may result in an indeterminable increase in local revenues as a result of convictions of knowingly or intentionally distributing, dispensing, producing or manufacturing, or creating, distributing, or possessing with intent to distribute a counterfeit controlled dangerous substance involving fentanyl or fentanyl packaging that is designed to resemble branded or generic prescription medication. The exact fiscal impact of the passage of this legislation on local revenue is indeterminable, as the fines that would be imposed on those convicted are variable in nature, and the number of fines that will be imposed on offenders convicted of <u>proposed law</u> is unknown. The potential revenue will accrue to the local governing authority.
