Amendments proposed by House Committee on Administration of Criminal Justice to
Original House Bill No. 67 by Representative Domangue

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" and before the comma "," change "R.S. 14:95(H)(1)" to
3 "R.S. 14:95(H)(1) and (K)(1) and (2)"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "for" delete the remainder of the line and delete line 4 in its entirety
6 and insert "certain persons; and to provide for related matters."

7 AMENDMENT NO. 3

8 On page 1, line 6, after "Section 1." and before "hereby" change "R.S. 14:95(H)(1) is" to
9 "R.S. 14:95(H)(1) and (K)(1) and (2) are"

10 AMENDMENT NO. 4

11 On page 1, line 17, after "investigators;" and before "the" insert "the governor; the lieutenant
12 governor; the secretary of state; the treasurer; the commissioner of agriculture; the
13 commissioner of insurance;"

14 AMENDMENT NO. 5

15 On page 2, line 1, after "presidents;" delete the remainder of the line and at the beginning
16 of line 2 delete "presidents;"

17 AMENDMENT NO. 6

18 On page 2, after line 5, add the following:

19 "K.(1) The provisions of this Section shall not prohibit a retired ~~or former~~
20 justice or judge of the supreme court, courts of appeal, district courts, parish courts,
21 juvenile courts, family courts, city courts, federal courts; former governor; former
22 lieutenant governor; former secretary of state; former treasurer; former commissioner
23 of agriculture; former commissioner of insurance; retired ~~or former~~ attorney general;
24 retired ~~or former~~ assistant attorneys general; retired ~~or former~~ district attorneys;
25 retired ~~or former~~ assistant district attorneys; retired ~~or former~~ United States
26 attorneys, retired ~~or former~~ assistant United States attorneys, or retired ~~or former~~
27 federal investigators; retired ~~or former~~ justices of the peace; retired ~~or former~~
28 members of the United States Congress; and former members of either house of the
29 legislature from possessing and concealing a handgun on their person provided that
30 such retired person or former member of the legislature is qualified annually, at their
31 expense, in the use of firearms by the Council on Peace Officer Standards and
32 Training and has on their person valid identification showing proof of their status as
33 a former member of the legislature or as a retired justice, judge, attorney general,
34 assistant attorney general, district attorney, assistant district attorney, United States
35 attorney, or assistant United States attorney or federal investigator, or retired justice
36 of the peace. For a former member of the legislature, the valid identification
37 showing proof of status as a former legislator required by the provisions of this
38 Paragraph shall be a legislative badge issued by the Louisiana Legislature that shall
39 include the former member's name, the number of the district that the former
40 member was elected to represent, the years that the former member served in the

1 legislature, and words that indicate the person's status as a former member of the
2 legislature.

3 (2) The retired or former justice, judge, governor, lieutenant governor,
4 secretary of state, treasurer, commissioner of agriculture, commissioner of insurance,
5 attorney general, assistant attorney general, district attorney, assistant district
6 attorney, justice of the peace, or former member of the United States Congress or
7 either house of the legislature shall be qualified annually in the use of firearms by the
8 Council on Peace Officer Standards and Training and have proof of qualification.

10 (3) This Subsection shall not apply to a retired or former justice, judge,
11 governor, lieutenant governor, secretary of state, treasurer, commissioner of
12 agriculture, commissioner of insurance, attorney general, assistant attorney general,
13 district attorney, assistant district attorney, United States attorney, assistant United
14 States attorney or federal investigator, retired justice of the peace, or to a former
15 member of the legislature or the United States Congress who is medically retired
16 based upon any mental impairment, or who has entered a plea of guilty or nolo
17 contendere to or been found guilty of a felony offense.
