AN ACT

To amend and reenact R.S. 13:991(A), relative to court costs; to provide relative to judicial expense funds of district courts; to provide relative to the judicial expense fund for the Nineteenth Judicial District Court; to increase filing fees and court costs in civil suits; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 13:991(A) is hereby amended and reenacted to read as follows:

§991. Judicial expense fund for nineteenth judicial district Nineteenth Judicial

<u>District</u>; established

A. In addition to all other fees or costs now or hereafter provided by law, the clerk of court of the Nineteenth Judicial District shall collect from every person filing any type of civil suit or proceeding and who is not otherwise exempted by law from the payment of court costs, a sum to be determined by the judges of said district, sitting en banc, which sum shall not exceed fifteen of sixty dollars, subject, however, to the provisions of Louisiana Code of Civil Procedure, Article 5181, et seq.; and, in all criminal cases over which the Nineteenth Judicial District Court has jurisdiction, there shall be taxed as costs against every defendant who is convicted after trial or after plea of guilty or who forfeits his bond, a sum likewise determined but which shall not exceed five dollars, shall be in addition to all other fines, costs

Abstract: Increases filing fees and court costs in civil suits for the 19th JDC.

<u>Present law</u> authorizes the 19th JDC to establish a judicial expense fund and to assess additional costs and civil charges in civil matters.

<u>Present law</u> requires the judges of the 19th JDC, sitting en banc, to determine a sum not to exceed \$15 that shall be collected or received by the clerk of court and placed in a separate account to be designated as the Judicial Expense Fund for the 19th JDC.

<u>Proposed law</u> removes the requirement of the judges of the 19th JDC, sitting en banc, to determine a sum not to exceed \$15 and fixes the sum at \$60.
