27	(24) (25) "Ruminant" includes any mammal of the suborder Ruminantia,
28	which includes but is not limited to cattle, buffalo, sheep, goats, deer, elk, and
29	antelopes.
30	$\frac{(25)}{(26)}$ "Ton" means a net weight of two thousand pounds avoirdupois.
31	$\frac{(26)}{(27)}$ "Value of the protein deficiency" means the value of the crude
32	protein as set by the state chemist times the difference between the guaranteed

 (a) The express words "WARNING: NOT FOR HUMAN CONSUMPTION
 THIS PRODUCT HAS NOT BEEN PASTEURIZED AND MAY CONTAIN HARMFUL BACTERIA". This statement shall be displayed in a conspicuous manner and shall not be smaller than the height of the minimum form required by the Federal Fair Packaging and Labeling Act for the net quantity statement in the table below:
