4 company;"

6 On page 2, line 5, after "**association**" delete "**which**" and insert "**. Status**"

7 AMENDMENT NO. 3

8 On page 2, line 9, after "**association.**" insert "**Status includes the lawful products and**  
9 **services provided by and lawful practices of firearm entities and firearm trade**  
10 **associations.**"

11 AMENDMENT NO. 4

12 On page 2, line 12, after "**association.**" insert "**Status includes the lawful products and**  
13 **services provided by and lawful practices of firearm entities and firearm trade**  
14 **associations.**"

24 **subdivision of the state, including but not limited to any political subdivision as**  
25 **defined in Article VI Section 44 of the Constitution of Louisiana, and any public**  
26 **housing authority, public school board, or any public officer whether or not an**  
27 **officer of a public corporation or political subdivision.**"

1 AMENDMENT NO. 10

3 **"(3) Notwithstanding the provisions of Paragraph (1) of this Subsection,**  
4 **the provisions of this Section shall not apply to a company in a multiple party**  
5 **contract that will receive less than one hundred thousand dollars over the term**  
6 **of the contract."**

7 AMENDMENT NO. 11

8 On page 4, between lines 13 and 14, insert the following:

9 **"D. The attorney general shall have authority to enforce the**  
10 **requirements of this Section, and if legal action is taken in which he prevails,**  
11 **then he shall be entitled to recover all reasonable costs and reasonable attorney**  
12 **fees incurred."**
