15 On page 4, at the beginning of line 18, after "<u>projects.</u>" delete the remainder of the line in 16 its entirety, delete lines 19 through 29 in their entirety, delete pages 5 through 8 in their 17 entirety, and on page 9, delete lines 1 through 10 in their entirety and insert the following:

- 18 "The board of a system may enter into agreements with one or more corporations to 19 administer and manage projects and may use alternative competitive procurement 20 and delivery methods with public advertisement for the award of any contracts for 21 the construction of any project in excess of one million dollars of total installed costs 22 if the board determines it is cost efficient and in the best interest of the board to 23 complete projects timely. However, the commissioner of administration, hereinafter referred to in this Paragraph as "commissioner", shall select the corporation or 24 25 corporations from a list of qualified corporations submitted by the board. The 26 commissioner and the director of the office of facility planning and control, hereinafter referred to in this Paragraph as "director", shall approve all cooperative 27 28 endeavor agreements entered into between the board, a corporation, and the state 29 prior to the commencement of any planning, design, or construction activities. Each 30 cooperative endeavor agreement shall set forth the requirements and responsibilities 31 of each party and shall also be in accordance with the guidelines and standards of 32 cooperative endeavor agreements administered by the office of facility planning and 33 control. Each cooperative endeavor agreement shall include an annual appropriation 34 dependency clause.
- 35 (ii) Monies to pay for the costs of projects shall be disbursed by the director
  36 within forty-five days of submission of project expenses to the director by the board.

- (b)(i) The provisions of Subparagraph (a) of this Paragraph shall not apply to any project with a total installed cost of less than one million dollars undertaken by a board pursuant to the provisions of this Part if the project is approved by the board, the commissioner, and the director.
- 5 <u>(ii) The director shall monitor projects undertaken by a board pursuant to the</u> 6 provisions of this Subparagraph.
- 7 (iii) Each board shall submit a written report every six months to the
  8 commissioner and the Joint Legislative Committee on Capital Outlay which contains
  9 information on the number of projects undertaken by the board, the percent of
  10 completion of each project, and the total amount of funds expended on each project.

11 (c) Any corporation entering into an agreement pursuant to the provisions 12 of this Part shall submit a written report every six months to the commissioner, the 13 director, and the Joint Legislative Committee on Capital Outlay which contains 14 information on the percent of completion of each project, the amount of monies 15 expended on each project, the amount of monies needed to complete each project, 16 and the expected timelines for completion of the construction of each project."
