Amendments proposed by Senate Committee on Insurance to Original Senate Bill No. 484 by Senator Duplessis

1 AMENDMENT NO. 1

2 On page 1, delete line 2, and insert the following:

3 "To amend and reenact R.S. 22:1483.1(A) and (C) and R.S. 44.1(B)(11), to  
4 enact R.S. 22:1483.1(B)(5) and (E)(3), and to repeal R.S. 22:1483(F),"

5 AMENDMENT NO. 2

6 On page 1, line 3, after "Program;" delete the remainder of the line, and delete lines 4  
7 through 8, and insert the following:

8 "to provide the commissioner of insurance may apply for grants or  
9 other funding, if available; to provide the commissioner of insurance may  
10 enter into certain agreements with public agencies and private entities; to  
11 require the grantee to submit to random reinspections; to provide certain  
12 information and records are confidential; to provide for an effective date; to  
13 repeal the"

14 AMENDMENT NO. 3

15 On page 1, line 11, after "Section 1." delete the remainder of the line, and delete line 12, and  
16 insert the following:

17 "R.S. 22:1483.1(A) and (C) are hereby amended and reenacted and R.S.  
18 22:1483.1(B)(5) and (E)(3) are hereby enacted to read as follows:"

19 AMENDMENT NO. 4

20 On page 2, delete lines 3 through 29, delete page 3, and on page 4, delete lines 1 through 7,  
21 and insert the following:

22 "**and regulations governing to govern the** eligibility requirements for grants  
23 and the administration of the program.

24 **(2) The commissioner may apply for grants or funds from the**  
25 **federal government or other funding sources to supplement the funds**  
26 **appropriated by the legislature. The commissioner may use grant funds**  
27 **to pay for inspections for grant applicants subject to the terms of the**  
28 **grant.**

29 **(3) The commissioner may enter into a cooperative endeavor**  
30 **agreement with public agencies and private entities for projects**  
31 **pursuant to this Section. A cooperative endeavor partner may**  
32 **administer grants or funds in the manner required by the cooperative**  
33 **endeavor agreement.**

34 B. In order to receive a grant pursuant to this Section, the grantee  
35 shall do all of the following:

37 **(5) Submit to random reinspection of the retrofitted insurable**

40 C.**(1)** The name of a recipient of a grant received pursuant to this  
41 Section, the amount of the grant, and the municipal address of the retrofitted  
42 insurable property shall be a public record.
