Amendments proposed by Senate Committee on Insurance to Original Senate Bill No. 484 by Senator Duplessis

1 AMENDMENT NO. 1

2 On page 1, delete line 2, and insert the following:

3 "To amend and reenact R.S. 22:1483.1(A) and (C) and R.S. 44:1(B)(11), to
4 enact R.S. 22:1483.1(B)(5) and (E)(3), and to repeal R.S. 22:1483.1(F),"

5 AMENDMENT NO. 2

6 On page 1, line 3, after "Program;" delete the remainder of the line, and delete lines 4
7 through 8, and insert the following:

8 "to provide the commissioner of insurance may apply for grants or
9 other funding, if available; to provide the commissioner of insurance may
10 enter into certain agreements with public agencies and private entities; to
11 require the grantee to submit to random reinspections; to provide certain
12 information and records are confidential; to repeal the"

13 AMENDMENT NO. 3

14 On page 1, line 11, after "Section 1." delete the remainder of the line, and delete line 12, and
15 insert the following:

16 "R.S. 22:1483.1(A) and (C) are hereby amended and reenacted and R.S.
17 22:1483.1(B)(5) and (E)(3) are hereby enacted to read as follows:"

18 AMENDMENT NO. 4

19 On page 2, delete lines 3 through 29, delete page 3, and on page 4, delete lines 1 through 7,
20 and insert the following:

21 "~~and regulations governing to govern the~~ eligibility requirements for grants
22 and the administration of the program.

23 **(2) The commissioner may apply for grants or funds from the**
24 **federal government or other funding sources to supplement the funds**
25 **appropriated by the legislature. The commissioner may use grant funds**
26 **to pay for inspections for grant applicants subject to the terms of the**
27 **grant.**

28 **(3) The commissioner may enter into a cooperative endeavor**
29 **agreement with public agencies and private entities for projects**
30 **pursuant to this Section. A cooperative endeavor partner may**
31 **administer grants or funds in the manner required by the cooperative**
32 **endeavor agreement.**

33 B. In order to receive a grant pursuant to this Section, the grantee
34 shall do all of the following:

36 **(5) Submit to random reinspection of the retrofitted insurable**
37 **property.**

38 C.(1) The name of a recipient of a grant received pursuant to this
39 Section, the amount of the grant, and the municipal address of the retrofitted
40 insurable property shall be a public record.

41 **(2) All information and records received pursuant to this Section**
42 **other than those listed in Paragraph (1) of this Subsection shall be**
43 **deemed confidential and exempt from disclosure pursuant to the Public**

1 **Records Law, R.S. 44:1 et seq. Nothing in this Subsection shall prevent**
2 **the use of such information or records for the compilation of statistical**
3 **data wherein the identity of the applicant, grantee, evaluator, or**
4 **contractor is not disclosed.**

6 E. This Section does not create any of the following:

8 **(3) A guarantee, warranty, or surety on the part of the state for**
9 **the performance of any obligation undertaken by an applicant,**
10 **evaluator, or contractor.**

12 Section 2. R.S. 44:4.1(B)(11) is hereby amended and reenacted to read as
13 follows:

14 §4.1. Exceptions

15 * * *

16 B. The legislature further recognizes that there exist exceptions,
17 exemptions, and limitations to the laws pertaining to public records
18 throughout the revised statutes and codes of this state. Therefore, the
19 following exceptions, exemptions, and limitations are hereby continued in
20 effect by incorporation into this Chapter by citation:
