BAIL: Requests the La. State Law Institute to study the feasibility of statewide bail schedules

A RESOLUTION

2	To urge and request the Louisiana State Law Institute to study and provide
3	recommendations relative to the feasability of statewide bail schedules and to submit
4	a report of its findings and recommendations to the legislature no later than thirty
5	days before the convening of the 2025 Regular Session.
6	WHEREAS, Article I, Section 18 of the Constitution of Louisiana provides for the
7	right to bail; and
8	WHEREAS, Title VIII of the Code of Criminal Procedure provides the statutory
9	guidelines for bail; and
0	WHEREAS, Code of Criminal Procedure Article 314 provides the following
1	magistrates with the authority to fix bail:
12	(1) District courts and their commissioners having criminal jurisdiction, in all cases.
13	(2) City or parish courts and municipal and traffic courts of New Orleans having
4	criminal jurisdiction, in noncapital cases.
15	(3) Mayor's courts and traffic courts in criminal cases within their trial jurisdiction.
16	(4) Juvenile and family courts in criminal cases within their trial jurisdiction.
17	(5) Justices of the peace in cases not capital or necessarily punishable at hard labor;

9	WHEREAS, Code of Criminal Procedure Article 315 provides that in noncapital
20	felony cases, a bail schedule according to the offense charged may be fixed by a district
21	court and in misdemeanor cases, a bail schedule according to the offense charged may be

1 fixed by a district, parish, or city court for offenses committed within its trial jurisdiction;

WHEREAS, the development of fixed schedules of bail applicable to all sixty-four

4 parishes provides uniformity relative to bail hearings within this state, regardless of the

5 parish where a criminal offense occurs.

THEREFORE, BE IT RESOLVED that the House of Representatives of the

Legislature of Louisiana does hereby urge and request the Louisiana State Law Institute to

study and provide recommendations relative to the feasability of statewide bail schedules

and to submit a report of its findings and recommendations to the legislature no later than

thirty days before the convening of the 2025 Regular Session.
