21 22 (B) When a precinct referenced in this Act has been subdivided by action of the parish governing authority on a nongeographic basis or subdivided by action of the parish governing authority on a geographic basis in accordance with the provisions of R.S. 18:532.1, the enumeration in this Act of the general precinct designation shall include all nongeographic and all geographic subdivisions thereof, however such subdivisions may be designated.

(C) The territorial limits of the districts as provided in this Act shall continue in effect until changed by law regardless of any subsequent change made to the precincts by the parish governing authority.

Section 3. (A) The provisions of Sections 1 and 2 of this Act shall become effective if and when a work point study by the National Center for State Courts is completed in accordance with House Concurrent Resolution No. 39 of the 2024 Regular Session of the Louisiana Legislature and the work point study concludes the additional district court judgeship is necessary.

(B) The provisions of this Section shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Section shall become effective on the day following such approval."
