1	AN ACT
2	To amend and reenact R.S. 40:1796, relative to preemption of state law; to provide relative
3	to the regulation of firearms; to provide with respect to the authority of political
4	subdivisions to regulate the sale, purchase, possession, ownership, transfer,
5	transportation, license, or registration of firearms or ammunition; to provide relative
6	to remedies; to provide relative to terms, conditions, and procedures; and to provide
7	for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 40:1796 is hereby amended and reenacted to read as follows:
10	§1796. Preemption of state law
11	A. No governing authority of a political subdivision shall enact after July 15,
12	1985, or enforce any ordinance, order, or regulation, policy, procedure, rule, or
13	any other form of executive or legislative action more restrictive than state law
14	concerning in any way the manufacture, sale, purchase, possession, carrying,
15	storage, ownership, transfer, transportation, license, or registration of
16	firearms, ammunition, or components of firearms or ammunition, firearms
17	accessories, knives, edged weapons, or any combination thereof. ; however, this
18	Section shall not apply to the levy and collection of sales and use taxes, license fees
19	and taxes and permit fees, nor shall it affect the authority of political subdivisions to
20	prohibit the possession of a weapon or firearm in the commercial establishments and
21	public buildings enumerated in R.S. 40:1379.3(N). Any existing ordinance, order,
22	regulation, policy, procedure, rule, or any other form of executive or legislative
23	action in violation of this Subsection shall be null and void, and of no effect.
24	B. A political subdivision shall repeal, rescind, or amend to conform, any
25	ordinance, order, regulation, policy, procedure, rule, or any other form of
26	executive or legislative action in violation of this Section within six months after
27	<u>August 1, 2024.</u>

1	C. A person or an organization whose membership is adversely affected
2	by any ordinance, order, regulation, policy, procedure, rule, or any other form
3	of executive or legislative action promulgated or caused to be enforced in
4	violation of this Section may file suit against an offending political subdivision
5	in any court of this state having jurisdiction for declatory and injunctive relief.
6	A court shall award a prevailing plaintiff in any such suit reasonable attorney
7	fees and costs including expert witness fees and expenses.
8	B.D. Nothing in this Section shall prohibit a local governing authority in a
9	high-risk area from developing a plan with federally licensed firearms
10	manufacturers, dealers, or importers to secure the inventory of firearms and
11	ammunition of those licensees in order to prevent looting of the licensee's premises
12	during a declared state of emergency or disaster. Such plan shall be renewed on a
13	periodic basis. The information contained in the plan shall be deemed security
14	procedures as defined in R.S. 44:3.1 and shall be released only to the sheriffs of the
15	parishes or police chiefs of municipalities in which the declared state of emergency
16	or disaster exists.
17	C.E. For the purposes of this Section:
18	(1) "Declared emergency or disaster" means an emergency or disaster
19	declared by the governor or parish president pursuant to the provisions of the
20	Louisiana Homeland Security and Emergency Assistance and Disaster Act.
21	(2) "High-risk area" means the parishes of Assumption, Calcasieu, Cameron,
22	Iberia, Jefferson, Lafourche, Orleans, Plaquemines, St. Bernard, St. Charles, St.
23	James, St. John, St. Martin, St. Mary, St. Tammany, Tangipahoa, Terrebonne, and
24	Vermilion.
25	F. This Section shall not apply to the levy and collection of sales and use
26	taxes, license fees and taxes, and permit fees, nor shall it affect the authority of
27	political subdivisions to prohibit the possession of a weapon or firearm in the
28	commercial establishments and public buildings enumerated in R.S.
29	<u>40:1379.3(N).</u>
