1	AN ACT
2	To authorize and provide for the transfer of certain state property; to authorize the transfer
3	of certain state property in Webster Parish; to provide property descriptions; to
4	provide for reservation of mineral rights; to provide terms and conditions; to provide
5	for an effective date; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. The commissioner of administration, notwithstanding any other provision
8	of law to the contrary, is hereby authorized and empowered to convey, transfer, assign, lease,
9	or deliver any interest, excluding mineral rights, the state may have to any portion of the
10	following described property in Webster Parish to those persons holding record title to that
11	portion of the property:
12 13 14 15 16	Those areas of dried lake bed existing above the current ordinary high water mark and below the 148.6 foot contour line according to NGVD29 elevation datum and lying within Sections 13 and 24 of Township 17 North - Range 10 West, Webster Parish, Louisiana, estimated to contain, in the aggregate, approximately 110 acres.
17	Section 2. The commissioner of administration is hereby authorized to enter into
18	such agreements, covenants, conditions, and stipulations and to execute such documents as
19	necessary to properly effectuate any conveyance, transfer, assignment, lease, or delivery of
20	title, excluding mineral rights, to portions of the property described in Section 1 of this Act,
21	and as more specifically described in any such agreements entered into and documents
22	executed by and between the commissioner of administration and the record title holder to
23	such property, in exchange for consideration proportionate to the appraised value of the
24	property.

1	Section 3. The commissioner of administration, notwithstanding any other provision
2	of law to the contrary, is hereby authorized and empowered to convey, transfer, assign, lease,
3	or deliver any interest, excluding mineral rights, the state may have to all or any portion of
4	the following described property in Webster Parish to Dale Farrar Furniss:
5 6	A 0.77 acre, more or less, tract of land located in Government Lot No. 4, Section 13, Township 17 North, Range 10 West, Webster Parish, Louisiana.
7	Section 4. The commissioner of administration is hereby authorized to enter into
8	such agreements, covenants, conditions, and stipulations and to execute such documents as
9	necessary to properly effectuate any conveyance, transfer, assignment, lease, or delivery of
10	title, excluding mineral rights, to portions of the property described in Section 3 of this Act,
11	and as more specifically described in any such agreements entered into and documents
12	executed by and between the commissioner of administration and Dale Farrar Furniss, in
13	exchange for consideration proportionate to the appraised value of the property.
14	Section 5. This Act shall become effective upon signature by the governor or, if not
15	signed by the governor, upon expiration of the time for bills to become law without signature
16	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
17	vetoed by the governor and subsequently approved by the legislature, this Act shall become
18	effective on the day following such approval.
