PUBLIC HEALTH. Provides for violence prevention. (8/1/24)

2	To enact R.S. 40:2025, relative to violence prevention in Louisiana; to provide for
3	legislative intent; to provide for review and reporting by the Louisiana Department
4	of Health; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 40:2025 is hereby enacted to read as follows:
7	§2025. Violence prevention
8	A. The legislature of the state of Louisiana declares that violence shall
9	be recognized and addressed as a public safety and health crisis utilizing a
10	public safety and health data-based approach.
11	B. The Louisiana Department of Health shall conduct a review of
12	violence prevention factors, activities, and strategies, taking into consideration
13	the following:
14	(1) The specifics of violence, including crimes of violence, gang violence,
15	and domestic violence in communities.
16	(2) The root causes of violence in the community, which may include
17	poverty, lack of quality education, lack of affordable housing, food insecurity,

1	unemployment, and untreated trauma.
2	(3) Community conditions, which may include a comparison of
3	community conditions and opportunities for communities with a high risk of
4	violence and those with a lesser risk of violence in order to identify and create
5	greater safety for high-risk communities through community surroundings. For
6	the purposes of this Section, community surroundings include but are not
7	limited to streets, parks, schools, community-based organizations, youth and
8	community centers, and places of worship.
9	(4) A commitment for violence prevention efforts to focus on addressing
10	and healing individual, interpersonal, and community trauma inflicted as a
11	result of violence.
12	C. The Louisiana Department of Health shall prepare a written report
13	to the legislature, no later than February 1, 2026, that provides information and
14	recommendations on the following:
15	(1) The current violence prevention activities occurring across Louisiana
16	state offices to outline the continuum of current activities related to violence
17	prevention.
18	(2) Promotional strategies for supporting conflict resolution and violence
19	prevention-related programs and services.
20	(3) Strategies for incorporating a public safety and health approach to
21	improve social determinants of safety and health for communities most affected
22	by violence.
23	D. The Louisiana Department of Health may coordinate with institutions
24	of higher learning and nongovernmental organizations to collect and evaluate
25	information in developing the recommendations to be presented to the
26	legislature.
