2	To amend and reenact R.S. 17:4002.3(2)(b) and the introductory paragraph of 4002.5(A) and
3	(A)(1) and (B), relative to the course providers; to provide with respect to
4	definitions; to provide with respect to student eligibility, course approval, and
5	enrollment; to provide relative to student individual graduation plans; to provide with
6	respect to the duties of the department; to provide with respect to the duties of the
7	State Board of Elementary and Secondary Education and public school governing
8	authorities; to provide for an effective date; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 17:4002.3(2)(b) and the introductory paragraph of 4002.5(A), (A) (1)
11	and (B) are hereby amended and reenacted to read as follows:
12	§4002.3. Definitions
13	As used in this Part, the following terms have the following meanings unless
14	the context clearly indicates otherwise:
15	* * *
16	(2) "Eligible funded student" means any student who resides in Louisiana and
17	meets the following criteria:

19	(b) Has obtained approval from the local school superintendent or other Has
20	consulted with the person designated by the governing authority of the school that
21	he attends to enroll in a course pursuant to this Part and has written permission
22	from a parent or legal guardian. Pursuant to R.S. 17:4002.5, the student shall
23	not be permitted to enroll in a course that conflicts with any of the following:
24	(i) A determination made by the student's school counselor that the
25	course is not to be academically appropriate considering the student's chosen
26	major or graduation pathway.
27	(ii) The department's published student high school planning resources.

2	§4002.5. Public school governing authority duties; accountability; rules
3	A. The governing authority of each public elementary and secondary school
4	shall establish policies and procedures whereby an eligible funded student may be
5	granted approval to enroll enrolls in a course pursuant to this Part, which shall also
6	provide for the following:
7	(1) Determination Advising the student and his parent or legal custodian
8	as part of the development and annual review of the student's Individual
9	Graduation Plan, pursuant to R.S. 17:2925 of whether a requested course is
10	academically appropriate for the student.

12	B. Each local public school system shall make available to all students
13	during the annual course enrollment process for the school system the course
14	catalogue as provided by the <b>department derived from a list of course providers</b>
15	approved by the state board during the annual course enrollment process for that
16	local school system.
17	* * *
18	Section 2. This Act shall become effective on July 1, 2025; if vetoed by the governor
19	and subsequently approved by the legislature, this Act shall become effective on the day
20	following such approval by the legislature or July 1, 2025, whichever is later.
