Amendments proposed by House Committee on Education to Re-Reengrossed Senate Bill No. 313 by Senator Edmonds

1 AMENDMENT NO. 1

2 On page 1, line 4, after "R.S. 17:5029(F)," and before "and to" insert "and R.S. 39:1554(T),"

3 AMENDMENT NO. 2

4 On page 1, line 5, after "choice;" and before "to create" insert "to require the state
5 Department of Education to report to the legislature relative to educational options that
6 receive state funding; to provide for the components of the report and a submission
7 deadline;"

8 AMENDMENT NO. 3

9 On page 1, line 15, before "definitions;" insert "procurement; to provide for"

10 AMENDMENT NO. 4

11 On page 4, at the end of line 29, change "R.S. 17:4037.4." to "R.S. 17:4037.5."

12 AMENDMENT NO. 5

13 On page 5, line 23, after "§4037.4." delete the remainder of the line and delete lines 24-26
14 and insert "School choice report"

15 AMENDMENT NO. 6

16 On page 8, between lines 23 and 24, insert the following:

17 "B. The department may enter into any contract for the administration
18 and management of the program or parts of the program subject to the
19 approval of the state board. Prior to execution of such a contract, the state
20 board shall transmit a copy of the timeline and process for the contract to the
21 Senate Committee on Education, the Senate Committee on Finance, the House
22 Committee on Education, the House Committee on Appropriations, and the
23 commissioner of administration for monitoring purposes."

25 On page 8, at the beginning of line 24, change "B.(1)" to "C.(1)"

26 AMENDMENT NO. 8

27 On page 9, at the beginning of line 5, change "C." to "D."

30 AMENDMENT NO. 10

31 On page 9, line 11, after "allocate" and before "to" insert "funds, in an amount determined
32 by the state board."

2 On page 15, delete lines 26-29

3 AMENDMENT NO. 12

4 On page 17, between lines 27 and 28, insert the following:

5 "Section 2. R.S. 39:1554(T) is hereby enacted to read as follows:

6 §1554. Application of this Chapter

7 * * *

8 **T. This Chapter shall not apply to any contract entered into by the state**
9 **Department of Education for administration of the LA GATOR Scholarship**
10 **Program or parts of the program as provided in R.S. 17:4037.5.**

11 Section 3. The state Department of Education may enter into a contract to manage
12 the program as provided for in R.S. 17:4037.5 as enacted by this Act in accordance with the
13 provisions of LAC 28:I.1103."
