17 "Third-party voter registration drive" means the solicitation, "(16) 18 distribution, or collection of voter registration applications by a third-party voter 19 registration organization.

20 (17) "Third-party voter registration organization" means any individual or entity that solicits, distributes, or collects voter registration applications and that is 21 not required by law to do so. "Third-party voter registration organization" shall not 22 23 include the following:

- (a) An individual who only seeks to encourage or assist a member of his 24 25 immediate family in registering to vote. 26
 - (b) A registrar of voters or employee thereof.

(c) The secretary of state or employee thereof who performs election duties. 27 28 (d) Any other individual or entity required by law to perform voter 29 registration activities. * * *" 30
