2	To amend and reenact R.S. 37:2354(D), 2355(B), 2359(A), the introductory paragraph of
3	2359(B), (E), and (G), and 2363(A), (B), and (D) and to enact R.S. 37:2352(12),
4	2354(B)(5) and (C)(5), 2356.4, and 2357(C), relative to licensed psychological
5	associates; to create a licensed psychological associate license; to provide for
6	qualifications and requirements for licensure; to provide for limitations of licensure;
7	to provide for powers and duties of the State Board of Examiners of Psychologists;
8	to provide for licensing fees; to provide for issuance, renewal, suspension, and
9	revocation of a psychological associate's license; to establish patient-provider
10	confidentiality; and to provide for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. 37:2354(D), 2355(B), 2359(A), the introductory paragraph of
13	2359(B), (E), and (G), and 2363(A), (B), and (D) are hereby amended and reenacted and
14	R.S. 37:2352(12), 2354(B)(5) and (C)(5), 2356.4, and 2357(C) are hereby enacted to read
15	as follows:

6	licensure as a licensed psychological associate that shall not exceed two hundred
7	dollars. The board shall adopt rules in accordance with the Administrative

10	(5)(a) Every licensed psychological associate in this state shall annually
11	pay to the board during the month of July of each year, beginning in the year
12	immediately subsequent to his initial license, a renewal fee that shall not exceed
13	three hundred dollars.

15	Paragraph shall cause the license to lapse. For a period of two years from the
16	date of lapse of the license, such license may be renewed upon payment of a
17	reinstatement fee equal to the application fee and renewal fee combined.

19	Procedure Act to implement the provisions of this Paragraph.

20	administrative records, communicated to a psychologist psychologist, a licensed
21	psychological associate, or a licensed specialist in school psychology licensed in
22	accordance with the provisions of this Chapter, or persons reasonably believed by
23	the patient or client to be so licensed, or to their employees or other persons under
24	their supervision, for the purpose of diagnosis, evaluation, or treatment of any mental
25	or emotional condition or disorder.
