Law. (8/1/24)

<u>Proposed law</u> authorizes the installation of newborn safety devices in any designated emergency care facility that is manned continuously on a 24-hour basis, 7 days a week, and 365 days a year. <u>Proposed law</u> requires the employee who mans the newborn safety device to be an emergency response provider who is certified in neonatal resuscitation and pediatric advanced life support. <u>Proposed law</u> designates emergency care facilities that install a newborn safety device to be responsible for 1) the cost of the installation, 2) installing an adequate dual alarm system connected to the safety device, 3) ensuring the device is cleaned and sanitized, 4) maintaining documentation of the testing of alarm system and cleaning of device, 5) installing a card holder with Safe Haven information and including other materials in an envelope to be readily available in the device for the relinquishing parent, 6) adopting written policies for receiving newborns who have been relinquished into safety devices, and 7) maintaining neonatal and pediatric resuscitation supplies.

### **EXPENDITURE EXPLANATION**

The proposed legislation is anticipated to increase Local Funds expenditures by an indeterminable amount as a result of local entities being responsible for the installation costs of the newborn safety device and other requirements including having designated emergency response providers with specialized certification as well as neonatal and pediatric resuscitation supplies. The newborn safety devices have an estimated cost of \$20,000 per device, which includes installation, electrical and alarm system hookup, and staff training. In addition, this measure requires the newborn safety devices to be manned for the required timeframe by an emergency response provider certified in neonatal resuscitation (NRP) and pediatric advanced life support (PALS) and further requires the maintenance of neonatal and pediatric supplies. Costs associated with these two requirements are indeterminable.

For informational purposes, the LFO received information from LSU Health that estimated the cost of 20 providers per hospital to continuously man a newborn safety device at approximately \$44 per hour per provider. To the extent local emergency care facilities will be required to pay or reimburse for the certifications in NRP and PALS, this measure will increase expenditures by an additional one-time cost of \$425 per provider (\$275 for NRP + \$150 for PALS = \$425).

The Department of Children and Family Services (DCFS) is the lead agency for Safe Haven law, and the LA Department of Health (LDH) is a member of the Safe Haven Consortium and works closely with DCFS on Safe Haven implementation. This measure would require DCFS to modify Safe Haven informational cards to be stocked within the safety device's card holder and including other materials in an envelope to be readily available in the device for the relinquishing parent. The department expects the cost of brochures and envelopes to be minimal and can be absorbed within its existing resources.

Information on the DCFS's website indicates there are three (3) emergency care facilities operated by LDH and designated as Safe Haven locations for the state - Central Louisiana State Hospital, Eastern Louisiana Mental Health System, and Villa Felicia Medical Complex. The proposed legislation would require these facilities to have emergency response providers certified in NRP and PALS to man the device 24 hours per day, 7 days per week, 365 days per year. LDH reports the proposed law is voluntary regarding the installation of newborn safety devices, and the department will not be installing safety devices.

### **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
