 36 Year 2024-2025 delineated by provider group, state agency, or managed care program. The
 37 reporting on the managed care expenditures shall differentiate between expenditures on the
 38 ACA Expansion population and the non-expansion population. The first report shall also
 39 include, for both the prior and current fiscal years, an itemization of supplemental or directed
 40 payment programs by provider group as well as all supplemental or directed payments and
 41 uncompensated care costs payments to the LSU Public Private Partnership hospitals. Finally,
 42 the report shall also provide the total amount of the expenditures on the Managed Care
 43 Incentive Program for both the prior and current fiscal years.

44 In the second report and each subsequent report submitted monthly thereafter, the
 45 department shall include a section detailing the budgeted means of financing versus the
 46 projected use of those means of financing to fund the projected expenditures and as adjusted
 47 for projected revenue collections by source. In the event a surplus is projected, the

1 department shall provide an explanation of the source of any surplus revenues and the
 2 rationale of the department’s proposed use of the means of financing. In the event a deficit
 3 is projected due to the budgeted means of finance or estimated revenue collections being
 4 insufficient to finance projected expenditures, the department shall inform the committee of
 5 any other sources of revenues that may be available or adjustments in expenditures that
 6 could be implemented within the department to aid in alleviating the projected deficit. Also
 7 beginning with the second report and continuing in each report submitted monthly thereafter,
 8 the department shall delineate, in the same manner as presented in the first report of the
 9 fiscal year, the initial allocation of payments, total projected expenditures, and year-to-date
 10 expenditures in Fiscal Year 2024-2025 for each allocation within the programs, the
 11 supplemental or directed payment programs, the supplemental or directed payments and
 12 uncompensated care costs payments to the LSU Public Private Partnership hospitals, and the
 13 total expenditures on the Managed Care Incentive Program.

14 Further, each report shall include a section specifying the total amount of pharmacy rebates
 15 projected to be received by the end of the fiscal year delineated between those generated by
 16 drug utilization of the expansion enrollees versus the non-expansion enrollees and, for the
 17 non-expansion enrollees, between those receiving health care services under the
 18 fee-for-service program versus the managed care program. In addition, each report shall
 19 include a section on current expansion and non-expansion enrollment in the Medicaid
 20 program and projected expansion and non-expansion enrollment through the end of the fiscal
 21 year.

22 Finally, each report shall include a thorough explanation of all policy changes proposed or
 23 implemented by the department since the preceding report was submitted to the committee,
 24 including but not limited to those being proposed or implemented by administrative rule
 25 making, state plan amendment, waiver application, or contract amendment. Such
 26 explanations shall include whether the policy change will result in an increase or decrease
 27 in revenue collections and/or expenditures.”
