Provides relative to the sale of raw milk

Proposed law provides labeling requirements for raw milk sold as animal feed. Proposed law allows the commissioner of agriculture and forestry to temporarily suspend the sale, distribution, or movement of any raw milk in the place where the raw milk originated from when raw milk causes an outbreak of a contagious or infectious disease that poses an immediate threat to animal or public health, and proposed law provides for procedures to override this suspension.
