HEALTH CARE/FACILITIES EGF INCREASE GF EX See Note Allows the provision of data relative to sickle cell disease

Proposed law requires the Louisiana Department of Health to facilitate an agreement between sickle cell clinics and an association that provides information and assistance to patients diagnosed with sickle cell disease. The agreement shall allow for the transfer of sufficient contact information from the sickle cell clinics to allow an association to contact the patient.

Proposed law provides each local public school board shall adopt a policy to require that each school nurse participates in an in-service training program of at least 1 hour relative to sickle cell disease. The school boards shall use instructional materials made available on the Louisiana State Board of Nursing's website. The training may be incorporated into an existing in-service training program.

EXPENDITURE EXPLANATION

LDH reports needing additional personnel resources to facilitate a data sharing agreement between providers and an association. LDH anticipates approximately \$39,000 for one (1) administrative specialist position to administer the agreements. The LFO has requested additional information from LDH to corroborate the need for this position.

There is no anticipated direct material effect on expenditures of the Louisiana Department of Education (LDOE) as a result of this measure. Training materials will be provided by the Sickle Cell Commission at no cost to the LDOE. Local school boards should not experience any impacts on expenditures, as the required training can be incorporated into scheduled in-services typically held for school nurses prior to the start of the school year.
