

1 WHEREAS, the information technology systems and services of the state should
2 incorporate the most effective technology available to ensure continuity of operations,
3 protection of state information, long-term cost savings through efficiency, and availability
4 of services to citizens of the state; and

5 WHEREAS, the division of administration, office of technology services, pursuant
6 to R.S. 39:15.1, is responsible for providing information technology systems and services
7 to cabinet departments in the executive branch of state government.

8 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
9 urge and request the division of administration, office of technology services, to study the
10 current status of the three oldest and the three most expensive information technology
11 systems used by agencies in the executive branch of state government to determine the risks
12 posed by continued use of such technology, the costs of continued operation of any such
13 outdated or ineffective information technology, and options and concerns regarding
14 transition to new technology systems including cloud-based services.

15 BE IT FURTHER RESOLVED that the office shall report its findings and
16 recommendations by January 1, 2025, in accordance with the following:

17 (1) The report shall include an executive summary and present findings for each
18 such system as well as findings that are not system specific.

19 (2) The report shall include the following:

20 (a) Identification of the three oldest information technology systems used by
21 agencies in the executive branch of state government; recommendations for improvements
22 of such systems; and potential costs and cost savings of such improvements.

23 (b) Identification of the three most expensive information technology systems used
24 by agencies in the executive branch of state government and an explanation of the cost, age,
25 and purpose of each such system as well as recommendations for improvements of each such
26 system and potential costs and cost savings of such improvements.

27 (c) Identification of points of risk of failure of these systems, estimates of the social
28 and economic impacts of any such failure, and potential costs and risk reductions gained by
29 updating such systems.

1 (d) Identification of risk of unauthorized access, loss or corruption of data, and
2 exposure to malicious software, the severity of such risks, estimates of the social and
3 economic impacts of any such attack, and potential costs and risk reductions gained by
4 updating such systems.

5 (e) Identification of technology fees and other sources of revenue that are dedicated
6 to technology needs of each agency with a covered system.

7 (f) Recommended priorities for upgrades considering all such costs, liabilities, and
8 benefits.

9 (g) Options and concerns regarding transition to new technology services including
10 cloud-based services.

11 (3)(a)(i) If the final report contains any information that would be exempt from
12 disclosure pursuant to any provision of the Public Records Law, the office shall deliver a
13 redacted copy of such report to the legislature in accordance with R.S. 24:772 with any
14 information in the report that would be exempt from disclosure pursuant to the Public
15 Records Law excised from such copy of the report. Such copy shall have each redacted
16 portion clearly marked with the provision or provisions of the Public Records Law that the
17 office believes applies to each such redaction.

18 (ii) The office shall deliver a separate report to the Joint Legislative Committee on
19 Technology and Cybersecurity that does not contain redactions, which shall be treated as
20 confidential and may only be discussed by the joint committee in executive session in
21 accordance with R.S. 24:672.

22 (b) If the final report does not contain any information that would be exempt from
23 disclosure pursuant to any provision of the Public Records Law, the office shall deliver the
24 report to the legislature in accordance with R.S. 24:772 and shall deliver a separate copy to
25 the Joint Legislative Committee on Technology and Cybersecurity.
