The source of 22 monies in the fund shall be the proceeds of any bonds issued pursuant to the 23 provisions of R.S. 17:3369.3; any monies transferred or appropriated by the 24 legislature including federal funds; all donations, gifts, or grants received by 25 the state for the fund; and any other monies which may be provided for the fund or the purposes of this Part by law. Deposits into the fund shall comply 26 27 with the provisions of Article VII, Section 9(B) of the Constitution of 28 Louisiana relative to the Bond Security and Redemption Fund. All 29 unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund. Monies in the fund shall be invested by the 30 31 treasurer in the same manner as monies in the state general fund and any 32 interest earned on the investment of such monies shall be deposited in and 33 credited to the fund. 34 B. Subject to appropriation, monies in the fund shall be used solely 35 and exclusively by the the Board of Supervisors of Louisiana State 36 University and Agricultural and Mechanical College, the Board of

30Oniversity and Agricultural and Weenanical Conege, the Doard of
Supervisors for the University of Louisiana System, the Board of Supervisors
of Southern University and Agricultural and Mechanical College, and the
Board of Supervisors of Community and Technical Colleges to pay expenses
associated with addressing deferred maintenance of public facilities under the
control of the board in accordance with the limitations and restrictions
provided for in this Part."
