MEDICAID RE INCREASE GF EX See Note  
Requires doula services to be covered by Medicaid. (8/1/24)

Proposed law provides Medicaid coverage (through the Managed Care Organizations, MCOs) for doula services before, during, and after childbirth. Proposed law specifies the specific doula services that are covered by Medicaid.

Proposed law provides that doulas opting in for reimbursement from Medicaid shall have approved registration with the Louisiana Doula Registry Board, and have acceptance as a provider from all MCOs.

**EXPENDITURE EXPLANATION**

Providing Medicaid coverage for inpatient and outpatient doula treatment services is anticipated to result in a significant increase in Medicaid expenditures annually.

As an illustrative example, if 5% of the approximately 35,196 eligible deliveries utilized doula services with a minimum service rate of \$1,250 per pregnancy, covering doula services could result in a minimum cost of \$2.2 M (\$385,965 SGF, \$121,584 Stat. Ded., and \$1,713,701 Federal) in FY 25, with projected increases in future fiscal years. The estimate is based on the following assumptions and calculations reflected below.

- 1) Approximately 35,196 Medicaid eligible deliveries from calendar year 2023
- 2) Minimum service rate of doula service per delivery = \$1,250 (the minimum rate is referenced in the proposed bill)
- 3) Assume MCOs will not reimburse at a higher level, otherwise cost estimates understated
- 4) 5% uptake in utilization of service with a 1% increase each year

**REVENUE EXPLANATION**

Increased premium payments to MCOs will result in additional taxes collected by LDH. Tax revenues are 5.5% of premiums paid to the MCOs. In the illustrative example in the Expenditure Explanation above, \$2.2 M in additional payments for doula covered services will generate approximately \$121,000 in statutory dedication premium tax revenues in FY 25.
