| 10 | charge to the children of this state at the elementary and secondary levels out of funds |
| 11 | appropriated therefor by the legislature in accordance with the requirement of the |
| 12 | Constitution of Louisiana"; and |
| 13 | WHEREAS, state law also provides for a review process by parents and members |
| 14 | of the public; and |
| 15 | WHEREAS, in an effort to maintain transparency about what students in Louisiana |
| 16 | are being taught in public school classrooms, there is growing interest in what materials are |
| 17 | used in classrooms that are procured outside of the standard process. |
