2	To enact R.S. 47:633(7)(e), relative to severance tax; to provide for rates of severance tax
3	on oil and gas; to provide for computation of severance tax amounts to be imposed
4	on oil and gas; to provide for exemptions from severance tax; to provide for
5	definitions; to provide for effectiveness; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 47:633(7)(e) is hereby enacted to read as follows:
8	§633. Rates of tax

12	(e) For purposes of this Paragraph, the following terms shall have the
13	following definitions:
14	(i) "Payout of well cost" shall be the cost of completing the well to the
15	commencement of production as reflected in the well cost statement submitted to the
16	Department of Energy and Natural Resources.
17	(ii) "Qualified accountant" means a certified public accountant ("CPA") who
18	meets all of the following qualifications:
19	(aa) Maintains an active unrestricted original certified public accountant
20	license.
21	(bb) Maintains a current Louisiana certified public accountant firm permit.
22	(cc) Actively participates in a Peer Review Program approved by the State
23	Board of Certified Public Accountants of Louisiana.
24	(iii) "Well cost statement" means a statement issued by a qualified accountant
25	who is unrelated to the operator and that is a report of the qualified accountant's

1	verification of the costs of completing the well to the commencement of production.
2	The well cost statement shall contain an opinion from the qualified accountant that
3	the well cost statement presents fairly, in all material aspects, the costs expended to
4	complete the well. The well cost statement shall:
5	(aa) Be performed in accordance with the accounting standards generally
6	accepted in the United States.
7	(bb) Be addressed to the party which has engaged the qualified accountant,
8	with a copy addressed to the operator.
9	(cc) Contain the qualified accountant's name, address, and telephone number.
10	(dd) Contain a certification that the qualified accountant is unrelated to the
11	operator.
12	(ee) Be dated as of the date of completion of the qualified accountant's field
13	work.
14	(ff) Contain a statement of acknowledgment by the qualified accountant that
15	the state is relying on the well cost statement in the allowance of an exemption under
16	the provisions of this Section.
17	* * *
18	Section 2. This Act shall become effective upon signature by the governor or, if not
19	signed by the governor, upon expiration of the time for bills to become law without signature
20	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
21	vetoed by the governor and subsequently approved by the legislature, this Act shall become
22	effective on the day following such approval.
