AN ACT

2 To enact R.S. 24:35.2 and to repeal R.S. 24:35.3, relative to redistricting; to provide for the
3 election districts for the House of Representatives of the Legislature of Louisiana;
4 to provide with respect to other positions and offices which are based upon such
5 districts; to provide for effectiveness; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 24:35.2 is hereby enacted to read as follows:

8 §35.2. Membership of the House of Representatives

9 The House of Representatives of the Legislature of Louisiana shall be
10 composed of one hundred five members. The state shall be divided into the
11 representative districts provided in this Section. One representative shall be elected
12 from each district.

Present constitution (Const. Art. Present law provides boundaries for 105 House districts based upon the 2020 federal decennial census.

Proposed law redraws district boundaries for the 105 House districts based upon the 2020 federal decennial census.


House - Shreveport HLS 25RS-51 (Jordan)




