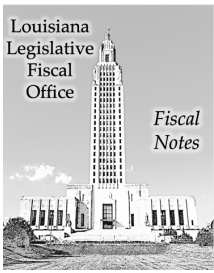

Provides for the authority of the Department of Insurance in instances of fraud. (gov sig)

Present law provides for the regulation of unfair trade practices in the business of insurance by the Commissioner of Insurance.

Proposed law prohibits any act that affects the business of insurance that is an unfair method of competition or an unfair or deceptive act or practice in the conduct of the business of insurance.

Proposed law provides that if the commissioner believes that any person not licensed by the department, but has engaged or is engaging in the business of insurance and committed or is committing any unfair trade practice, the commissioner may take action against the person. Nothing in proposed law precludes a person aggrieved by the commissioner's decision from seeking any other remedy provided by law.
