EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed legislation authorizes the board of the Jimmy D. Long, Sr. Louisiana School for Math, Science, and the Arts (LSMSA) explicit authority to develop a salary schedule, in accordance with the requirements of R.S. 17:418, for its teachers and other school employees. Funding for LSMSA is provided through SGF appropriations made directly to the school and funds appropriated through the Minimum Foundation Program (MFP) formula. Salaries set according to the newly developed salary schedule will also be funded via these methods. There is no anticipated cost to develop the salary schedule. Until the salary schedule is developed and adopted, any increases to SGF expenditures either directly or through the MFP formula, are indeterminable.
