<u>Present law</u> (C.C.P Art. 4843) provides for certain city courts, currently including the City Court of Hammond, to have jurisdiction concurrent with district courts in cases where the amount in dispute, or the value of the property involved, does not exceed \$30,000.

<u>Present law</u> provides for certain city courts to have jurisdiction concurrent with the district courts in cases where the amount in dispute, or the value of the property involved, does not exceed \$50,000.

<u>Proposed law</u> removes the City Court of Hammond from city courts in which jurisdiction is concurrent with district courts in cases where the amount in dispute, or the value of the property involved, does not exceed \$30,000, and adds the City Court of Hammond to city courts in which jurisdiction is concurrent with district courts where the amount in dispute, or the value of the property involved, does not exceed \$50,000.
