## WILDLIFE/FEES: Provides relative to the Department of Wildlife and Fisheries' annual duck stamps

1	AN ACT
2	To amend and reenact R.S. 56:153, relative to annual duck stamps; to remove fees for
3	resident and nonresident duck stamps; and to provide for related matters.
4	Be it enacted by the Legislature of Louisiana:
5	Section 1. R.S. 56:153 is hereby amended and reenacted to read as follows:
6	§153. Design, marketing, and sale of duck stamps and prints
7	The department shall provide by regulation for the annual creation of duck
8	stamps and duck stamp prints, the manner of selection of an artist and the manner of
9	reproduction, distribution, marketing and sale of such stamps and prints. Purchase
10	of such stamps and prints shall not authorize the purchaser to hunt, take, possess, or
11	transport ducks in the state of Louisiana. The secretary is hereby authorized to sell
12	such stamps and prints by the method he deems to be most beneficial to the
13	department, including public or private auction or direct sale to an individual, group,
14	or organization. The cost for a resident duck stamp shall be five dollars and fifty
15	cents and the cost for a nonresident duck stamp shall be twenty-five dollars. The
16	department shall retain exclusive ownership and production rights to the design for
17	reproduction of duck stamps and prints to sell to hunters, collectors, and other
18	interested persons. Upon completion of this process, the original artwork shall be
19	returned to the artist.

Abstract: Removes obsolete provision of law establishing fees for resident and nonresident duck stamps, which were required for the taking of migratory waterfowl under prior law.

<u>Present law</u> provides for a La. Duck License, Stamp, and Print Program to fund projects to protect and preserve migratory waterfowl recreation and tourism in the state through the sale of duck licenses and duck stamps and prints.

<u>Present law</u> requires the purchase of a resident or nonresident duck license for the taking of migratory waterfowl and establishes fees for the purchase of these licenses.

<u>Present law</u> also requires the Dept. of Wildlife and Fisheries to provide by rule for the creation, marketing, and sale of an annual duck stamp and print. The dept. is further required to provide by rule for the selection of artwork to be used and the manner of reproduction for the annual duck stamp and print.

<u>Present law</u> authorizes the secretary of the dept. to sell these stamps and prints by the method deemed most beneficial to the department, and includes authorization to sell the stamps and prints at public or private auction or directly to individuals, groups, and organizations.

<u>Present law</u> provides that the purchase of annual duck stamps and prints are not required for taking waterfowl, nor do they convey any privileges related to hunting, taking, possessing, or transporting ducks in the state.

Proposed law retains present law.

Present law also contains fees for resident and nonresident duck stamps.

<u>Proposed law</u> removes <u>present law</u> as an obsolete provision from <u>prior law</u> that required the purchase of both a resident or nonresident license and a resident or nonresident stamp to take migratory waterfowl.
