Section 1. R.S. 32:71(B)(2) is hereby amended and reenacted to read as follows:

§71. Driving on right side of road; exceptions

> (2) In addition to the requirement of Paragraph 1 hereof, any Any vehicle proceeding on a multilane highway at a speed slower than ten miles per hour less than the posted maximum speed limit shall be driven in the right hand lane then available for traffic, or as close as practicable to the right hand curb or edge of the roadway, except when overtaking and passing a vehicle proceeding in the same direction or when preparing for a left turn at an intersection or into a private road or driveway. Persons in violation of this Paragraph shall be punished by a fine of not more than one hundred dollars, or by imprisonment for not more than thirty days, or

2 (a) A fine of one hundred fifty dollars for the first offense.
3 (b) A fine of two hundred fifty dollars for a second subsequent offense

<u>Present law</u> provides vehicles driven at a speed of 10 miles per hour less than the posted speed limit in the left lane, other than for practicable purposes, are fined \$100 or less, or no more than 30 days imprisonment, or both.

<u>Proposed law</u> removes the 10 miles per hour or less parameter for the purposes of punishment.

<u>Proposed law</u> further changes the fine <u>from</u> \$100 or less <u>to</u> a first offense of \$150, second offense of \$250, and third offense of \$350. <u>Proposed law</u> further allows imprisonment of up to 30 days for a third subsequent offense within a 12 month period of the first offense or imprisonment up to 30 days, or both.

Effective August 1, 2025.
