Provides relative to Joint Legislative Committee on the Budget approval of capital outlay change orders

Proposed legislation increases the threshold for Joint Legislative Committee on the Budget (JLCB) <u>approval</u> for capital outlay change orders from \$100,000 per month to \$250,000 and increases the threshold for JLCB <u>review</u> from \$50,000 to \$100,000 to \$50,0000 to \$250,000.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed legislation reduces the number of change orders that will require formal approval from the Joint Legislative Committee on the Budget (JLCB) by increasing the minimum cost for approval from \$100,000 to \$250,000. JLCB is still required to review all change orders over \$50,000 and under \$250,000.
