5	WHEREAS, Coca-Cola UNITED's story in Louisiana began in 1906, when visionary
6	entrepreneur Thomas Daigre founded the Baton Rouge Coca-Cola Bottling Company in a
7	modest building at the corner of Europe and St. Louis streets in Baton Rouge, establishing
8	a cornerstone for a company that would grow to become an integral part of Louisiana's
9	economic and cultural fabric; and
10	WHEREAS, for more than 130 years, Coca-Cola UNITED, now a vital privately
11	owned Coca-Cola bottler, has proudly operated in Louisiana, expanding its offerings to a
12	diverse portfolio of more than 750 beverage options and placing a growing emphasis on
13	low-calorie and sugar-free choices, reflecting its commitment to evolving consumer needs
14	and health-conscious lifestyles; and
15	WHEREAS, Coca-Cola UNITED currently operates seven facilities throughout
16	Louisiana - including five sales and distribution centers and two production plants-providing
17	meaningful employment to over 2,400 dedicated Louisianians and contributing significantly
18	to the state's economy; and

1	WHEREAS, as a locally owned and operated employer, Coca-Cola UNITED sustains
2	thousands of Louisiana jobs and continues to be a preferred beverage provider for consumers
3	across the state, contributing an estimated \$937 million in economic impact annually, plus
4	an additional \$38 million through purchases from local suppliers-supporting over 14,730
5	jobs in related industries; and

6 WHEREAS, over the past five years, Coca-Cola UNITED has demonstrated its
7 long-term commitment to Louisiana by investing over \$150 million in capital improvements,
8 strengthening infrastructure, and ensuring continued growth; and

9 WHEREAS, Coca-Cola UNITED is deeply committed to community well-being,
 10 generously supporting civic and charitable organizations across Louisiana with
 11 approximately \$6.5 million in annual investments in community programs; and

WHEREAS, the company has also taken a national leadership role in addressingchildhood obesity; and
