2	To amend and reenact R.S. 1/:1964(D)(5), relative to the Jimmy D. Long, Sr. Louisiana
3	School for Math, Science, and the Arts; to provide for the salary schedule established
4	by the board of directors for teachers and other school employees; to provide for the
5	funding of the salaries; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 17:1964(D)(5) is hereby amended and reenacted to read as follows:
8	§1964. Board of directors; creation; membership; terms; powers, duties, and
9	functions; voting; compensation

11	D. In addition to the authorities granted herein and any powers, duties, and
12	responsibilities vested by any other applicable laws, the board shall:

14	(5)(a) Determine faculty and staff positions necessary for the efficient
15	operation of the school and select personnel for such positions.

Abstract: Provides relative to the salary schedule for employees of the Jimmy D. Long, Sr. School for Math, Science, and the Arts and for the funding of the salaries.

<u>Present law</u> provides for the Jimmy D. Long, Sr. Louisiana School for Math, Science, and the Arts (LSMSA) as a state school governed by a board of directors. <u>Proposed law</u> retains present law.

<u>Present law</u> generally requires all school boards to establish a salary schedule by which to determine the salaries to be paid to teachers and other school employees. <u>Proposed law</u> retains <u>present law</u> and adds this as a specific requirement under the board's enumerated powers and duties.

<u>Present law</u> provides that funding for LSMSA is provided through legislative appropriations made directly to the school from the state general fund and through funds appropriated through the minimum foundation program formula. <u>Proposed law</u> retains <u>present law</u> and specifies that the cost of the salaries shall be paid from funds appropriated therefor by the legislature.
