AN ACT

HIGHWAYS: Designates certain portions of Louisiana Highways

2	To designate a portion of Louisiana Highway 466 in the city of Gretna, between Franklin
3	Street and Huey P. Long Avenue, as the "Chief B.H. Miller, Jr. Memorial Parkway";
4	to designate the elevated portion on Louisiana Highway 31 in St. Martin Parish as
5	the "Coach Raymond Lavergne Sr. Memorial Bridge"; to designate a portion of
6	Louisiana Highway 26 in Jefferson Davis Parish as "Dr. Martin Luther King
7	Memorial Highway"; to designate a portion of North Frontage Road in Jefferson
8	Davis Parish as "Representative John E. Guinn Memorial Highway"; to designate the
9	portion of Louisiana Highway 20, at the intersection of Louisiana Highway 20 and
10	Louisiana Highway 307 to the LaFourche and St. James Parish line as the "Martha
11	Ann Woods-Shareef Highway"; and to provide for related matters.
12	Be it enacted by the Legislature of Louisiana:
13	Section 1. The portion of Louisiana Highway 466 in the city of Gretna, between
14	Franklin Street and Huey P. Long Avenue, shall be known and is hereby designated as the
15	"Chief B.H. Miller, Jr. Memorial Parkway".
16	Section 2. The elevated portion of Louisiana Highway 31 in the town of
17	Arnaudville, St. Martin Parish, which crosses Bayou Fuselier, shall be known and is hereby
18	designated as the "Coach Raymond Lavergne Sr. Memorial Bridge".
19	Section 3. The portion of Louisiana Highway 26 in Jefferson Davis Parish, within
20	the city limits of Jennings, between Baker Street and West Racca Road, shall be known and
21	is hereby designated as "Dr. Martin Luther King Memorial Highway".

1 Section 4. The portion of North Frontage Road in Jefferson Davis Parish, in the city

2 of Jennings, between North Cutting Avenue and Louisiana Highway 97, shall be known and

- 3 is hereby designated as "Representative John E. Guinn Memorial Highway";
- 4 Section 5. The portion of Louisiana Highway 20, at the intersection of Louisiana
- 5 Highway 20 and Louisiana Highway 307 to the LaFourche and St. James Parish line, shall
- 6 be known and is hereby designated as the "Martha Ann Woods-Shareef Highway."
- 7 Section 6. The Department of Transportation and Development is hereby directed
- 8 to erect and maintain appropriate signage reflecting these designations provided local or
- 9 private monies are received by the department equal to the department's actual costs for
- material, fabrication, mounting posts, and installation of each sign, not to exceed the sum
- of five hundred fifty dollars per sign.

Designates the portion of La. Hwy. 466 in the city of Gretna, between Franklin Street and Huey P. Long Avenue as the "Chief B.H. Miller, Jr. Memorial Parkway".

Designates the elevated portion of La. Hwy. 31 in the town of Arnaudville, which crosses Bayou Fuselier as the "Coach Raymond Lavergne Sr. Memorial Bridge".

Designates the portion of La. Hwy. 26 in Jefferson Davis Parish as the "Dr. Martin Luther King Memorial Highway".

Designates a portion of North Frontage Road in Jefferson Davis Parish as "Representative John E. Guinn Memorial Highway".

Designate the portion of La. Hwy. 20, at the intersection of La. Hwy. 20 and La. Hwy. 307 to the LaFourche and St. James Parish line as the "Martha Ann Woods-Shareef Highway".

Directs the Dept. of Transportation and Development (DOTD) to erect and maintain appropriate signage reflecting these designations provided local or private monies are received by DOTD equal to its actual costs for material, fabrication, mounting posts, and installation of each sign, not to exceed the sum of \$550 per sign.

## Summary of Amendments Adopted by House
