Provides relative to the payment of insurance premium costs by the Franklin Parish Sheriff's Office

Purpose of this Bill: This bill requires Franklin Parish Sheriff's Office (FPSO) to pay group insurance premium costs for sheriffs and deputy sheriffs who earned a majority of their credible service time with the FPSO, retires from any sheriff's office of this state, the La. Sheriff's Association, or the La. Sheriff's Pension and Relief Fund on or after Jan. 1, 2025, and is eligible to receive benefits from the Sheriff's Pension and Relief Fund. The payments will be as follows:

- 1. 100% if the sheriff or deputy sheriff has completed 30 years of full-time creditable service time with the FPSO, regardless of age
- 2. 75% if the sheriff or deputy sheriff has attained the age of 55 with at least 27 years of full-time creditable service time with the FPSO
- 3. 50% if the sheriff or deputy sheriff has attained the age of 55 with at least 23 years of full-time creditable service time with the FPSO

The measure also clarifies that the Louisiana Sheriff's Pension and Relief Fund determines the creditable days of full-time service for all retirees under this subsection.
