 Provides relative to the amount DPS&C pays for the housing of state inmates in a parish jail or institution

Current law provides that the Department of Public Safety and Corrections (DPS&C) shall pay \$25.39 per day for the confinement of persons in parish jails or institutions for Fiscal Year 2019-2020; provides that the DPS&C shall pay \$26.39 per day for the confinement of persons in parish jails or institutions for Fiscal Year 2020-2021 and each fiscal year thereafter. Proposed law increases the amount that DPS&C pays for the confinement of persons in parish jails or institutions at the following rates for fiscal years as follows - for FY 26, \$35 per day; for FY 27, \$37 per day; for FY 28, \$39 per day; for FY 29 and each fiscal year thereafter, \$40 per day; removes requirement that basic jail guidelines are amended by 12/31/20 relative to treatment and educational programming for individuals confined in a parish jail or institution.

EXPENDITURE EXPLANATION

Proposed law will result in an increase of \$49.7 M SGF expenditures in FY 26 for the Department of Public Safety and Corrections - Local Housing of State Adult Offenders, with additional increases in subsequent fiscal years, for the Department of Public Safety and Corrections to increase the amount that it pays for the confinement of persons in parish jails and institutions. The increases are as follows:

Annual Cost = LHSAO Population (15,810) x Daily Rate x 365 Days
 Annual Increase = Annual Cost in Future Fiscal Year - FY 25 Annual Cost

Note: The estimates above were calculated considering the population of Local Housing of State Adult Offenders as constant (12,680 budgeted local housing offenders, 1,139 parole holds, and 1,991 transitional work program offenders). The above estimates can either decrease or increase, depending upon the population of offenders housed within parish jails and institutions and the number of days in which they are housed.
