ELECTION OFFENSES. Prohibits betting or wagering on elections. (8/1/25)

2	To enact R.S. 18:1461.7(A)(10), relative to election offenses; to prohibit betting or wagering

4	Be it enacted by the Legislature of Louisiana:
5	Section 1. R.S. 18:1461.7(A)(10) is hereby enacted to read as follows:
6	§1461.7. Miscellaneous election offenses; penalties
7	A. No person shall knowingly, willfully, or intentionally:
8	* * *
9	(10) Participate in any bet or wager that is based upon any contingency
10	whatsoever that arises from an election conducted pursuant to this Title,
11	including any of the following:
12	(a) Making an offer to bet or wager on an election.
13	(b) Accepting a bet or wager on an election.
14	(c) Taking a share or monetary interest in a bet or wager on an election.
15	(d) Providing money to be used by another person in making a bet or
16	wager on an election.
17	(e) Act in any manner to become a party to a bet or wager on an election.

Edmonds

<u>Present law</u> provides that it is unlawful for a person to knowingly, willfully, or intentionally commit any of the following election offenses:

- (1) Failure to submit to the parish registrar of voters a completed registration application collected through a third-party voter registration drive within 30 days of receipt of the completed application.
- (2) Allow a ballot to be seen or announced in a manner that violates a voter's right to a secret ballot.
- (3) Failure to mark the ballot or vote in the manner dictated by the voter, when the voter requires assistance.
- (4) Knowingly making a false medical certification regarding the disability of the voter.
- (5) Transmit or otherwise provide false or misleading information concerning an election from a source disguised to appear or impersonating the secretary of state, a registrar of voters, a clerk of court, or other election official.
- (6) Facilitate the distribution and collection of an application for an absentee ballots or an absentee ballot in violation of <u>present law</u>.

<u>Present law</u> provides that the penalties for violating an election offense under <u>present law</u> is a fine of not more than \$1,000 or imprisonment for not more than one year, or both, for the first offense. On a second or any subsequent offense, the penalty is a fine of not more than \$2,500 or imprisonment for not more than five years, or both.

<u>Proposed law</u> retains <u>present law</u> but adds betting or wagering on an election to the list of election offenses.

Effective August 1, 2025.
