2	To amend and reenact R.S. 34:2, relative to ports and harbors; to provide relative to the
3	membership of the Board of Commissioners of the Port of New Orleans; to require
4	Senate confirmation of board members; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 34:2 is hereby amended and reenacted to read as follows:
7	§2. Confirmation not required; removal; procedure
8	All appointments of members of the board shall be made by the governor as
9	provided in this Subpart without the need for confirmation by the Senate, subject to
10	Senate confirmation. No member thus appointed shall be removed except for cause
11	on charges preferred against him in writing by the attorney general and after public
12	hearing and proof of the sufficiency of the changes to justify his removal, before a
13	commission of three disinterested citizens residing within the jurisdictional area of
14	this port, one to be appointed by the governor, one to be appointed by the president
15	of Tulane University of Louisiana, and one to be appointed by the president of
16	Loyola University in New Orleans; however, any member so removed shall have the
17	right to test in the courts the sufficiency of the charges and the evidence in support

Section 2. This Act shall apply only to persons appointed to the board on or after

3 August 1, 2025.

<u>Present law</u> provides that all members of the Board of Commissioners of the Port of New Orleans will be made by the governor without confirmation by the Senate. Provides the requirements for removal of a member by public hearing and the process by which a commission is formed of three disinterested citizens residing within the jurisdictional area of this port. Provides for how the commission is selected with one member appointed by the governor, one member appointed by the president of Tulane University, and one member appointed by the president of Loyola University in New Orleans. Provides that any member removed has the right to test in the courts the sufficiency of the charges and the evidence in support of the charges.

<u>Proposed law</u> provides that an appointment to the board is subject to Senate confirmation.

Proposed law otherwise retains present law.

Proposed law only applies to persons appointed to the board on or after August 1, 2025.

Effective August 1, 2025.
