Amendments proposed by Senator Mizell to Engrossed Senate Bill No. 161 by Senator Mizell

AMENDMENT NO. 1

On page 1, line 4, after "to repeal" change "R.S. 47:6007(A)(18)" to "R.S. 47:6007(B)(18)"

AMENDMENT NO. 2

On page 4, at the beginning of line 12, delete "**statutorily dedicated fund account**" and insert "**fund**"

AMENDMENT NO. 3

On page 4, at the end of line 13, after "**fund**." insert "**After compliance with the requirements of Article VII, Section 9(B) of the Constitution of Louisiana relative to the Bond Security and Redemption Fund, all monies received for the purpose of the fund shall be deposited into the fund.**"

AMENDMENT NO. 4

On page 4, line 14, after "**(2)**" delete the remainder of the line and delete line 15 and insert "**Monies in the fund shall be used solely for economic**"

AMENDMENT NO. 5

On page 4, delete lines 19 through 28 and insert the following:

**"(3) The source of monies in the fund shall be any monies transferred or appropriated by the legislature, grants, donations, or other monies which may become available."**

AMENDMENT NO. 6

On page 4, line 29, delete "**money in the account**" and insert "**monies in the fund**"

AMENDMENT NO. 7

On page 5, line 1, after "**in the**" and before "**general**" delete "**state**"

AMENDMENT NO. 8

On page 5, delete lines 2 and 3 and insert "**investment of monies in the fund shall be credited back to the fund.**"

AMENDMENT NO. 9

On page 5, at the beginning of line 4, delete "**Security and Redemption Fund.**"

AMENDMENT NO. 10

On page 5, line 5, after "**remaining in the**" delete "**account**" and insert "**fund**"

AMENDMENT NO. 11

On page 5, line 6, delete "**account**" and insert "**fund**"

2 On page 6, delete lines 6 and 7 and insert:
