Relative to municipal, parish, and state governmental entities, provides for conditions pertaining to security for the issuance of permits for outdoor events and the release of certain surveillance video

Proposed law provides that any governmental entity, whether at the state, parish, or municipal level shall meet certain requirements to issue permits for any outdoor events. Proposed law requires governmental entities to submit a master plan for any outdoor event, which shall detail the physical parameters, total occupancy, and the placement of law enforcement. Proposed law provides that the master plan must be approved by the law enforcement agency providing the security, and authorizes law enforcement to terminate any event that does not comply.

Proposed law prohibits any governmental entity from releasing surveillance video of any violent crime, except when directed by a court order or subpoena. Proposed law outlines that any governmental entity that releases surveillance video of a violent act without a court order or subpoena is subject to a civil fine of up to \$5,000, that shall be paid to the victim of the violent act.

EXPENDITURE EXPLANATION

Proposed law may result in a, likely minimal, increase in SGF or Local Funds expenditures. Proposed law prohibits any governmental entity from releasing surveillance video of any violent crime, except when directed by a court order or subpoena. Proposed law outlines that any governmental entity that releases surveillance video of a violent act without a court order or subpoena is subject to a civil fine of up to \$5,000 that shall be paid to the victim of the violent act. To the extent that state agencies, municipalities, or parish governments do not comply with the proposed law a corresponding increase in SGF or Local Fund expenditures is anticipated. The exact fiscal impact of the passage of the proposed law is indeterminable, since it is not known how many, if any, instances will have civil penalties imposed as a result of proposed law.

Proposed law may increase the workload for governmental entities to implement new procedures around outdoor events. Proposed law requires governmental entities and event organizers to provide a master plan to law enforcement, and obtain approval from the law enforcement agency providing security. The Office of State Buildings (OSB) reports they may need to modify event permitting process to implement the requirements of the master plan. OSB anticipates implementing the proposed law using existing staff and resources. Proposed law may increase the workload for municipalities or parish governmental entities; however the LFO anticipates any such increase to be minimal.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
