3	(D) and to enact R.S. 17:3138.7(B)(25) and (26) and (G)(1)(l), relative to the

5	membership of the council; to provide for payment of certain expenses; to provide

<u>Present law</u> provides for the Advisory Council on Historically Black Colleges and Universities (HBCUs) and requires the council to advise the commissioner of higher education and the Bd. of Regents regarding best practices for strengthening HBCUs.

REENGROSSED HB NO. 142

<u>Proposed law</u> increases the council's membership <u>from</u> 24 <u>to</u> 26 by adding the chancellor of Southern University and Agricultural and Mechanical College and an at-large member appointed by the chairman of the council.

<u>Present law</u> requires one member to be a student serving as student body president of an HBCU in La. <u>Proposed law</u> authorizes the Bd. of Regents to pay for certain expenses for such member.

<u>Present law</u> requires one member to be the president of the American Civil Liberties Union (ACLU) of La. <u>Proposed law</u> removes this member.

<u>Proposed law</u> requires one member to be the president of the La. Legislative Black Caucus (LLBC) Foundation.

<u>Proposed law</u> requires the council to help identify methods to share best practices regarding campus safety.

(Amends R.S. 17:3138.7(B)(intro. para.) and (5)-(24) and (D); Adds R.S. 17:3138.7(B)(25) and (26) and (G)(1)(1))

#### Summary of Amendments Adopted by House

#### The House Floor Amendments to the engrossed bill:

- 1. Remove the president of the ACLU of La. from the council.
- 2. Add the president of the LLBC Foundation to the council.
