Amendments proposed by Representative Brass to Engrossed House Bill No. 517 by Representative Brass

## 1 AMENDMENT NO. 1

- 2 On page 1, line 2, after "R.S. 47:841(F)" and before the comma "," insert "and to enact R.S.
- 3 47:841.2"
- 4 AMENDMENT NO. 2
- 5 On page 1, line 4, after "calculated;" and before "to provide" insert the following:
- "to establish the Youth Cessation and Prevention Fund as a special fund in the state treasury; to provide for the transfer, deposit, and use of the monies in the fund;"
- 8 AMENDMENT NO. 3
- 9 On page 1, line 8, after "reenacted" and before "to" insert "and R.S. 47:841.2 is hereby
- 10 enacted"
- 11 AMENDMENT NO. 4
- 12 On page 1, after line 20, insert the following:
- 13 "§841.2. Youth Cessation and Prevention Fund
- A. There is hereby created as a special fund in the state treasury the "Youth Cessation and Prevention Fund", hereinafter referred in this Section as the "fund".

  After satisfying the requirements of Article VII, Section 9(B) of the Constitution of Louisiana relative to the Bond Security and Redemption Fund and after a sufficient amount is allocated from that fund to pay all of the obligations secured by the full faith and credit of the state which become due and payable within any fiscal year, the state treasurer shall annually deposit into the fund an amount equal to twenty percent
- of the avails of the tax imposed pursuant to the provisions of R.S. 47:841(E).
- B. All unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund. The monies in the fund shall be invested by the state treasurer in the same manner as monies in the state general fund and all earnings on investment of monies in the fund shall be deposited into the fund.

  Monies appropriated from the fund shall be used solely as provided in Subsection C
- 27 <u>of this Section.</u>
- 28 <u>C. Subject to an annual appropriation by the legislature, monies in the fund</u> 29 shall be appropriated as follows:
- 30 (1) Forty percent to the Louisiana Cancer Research Center, established
  31 pursuant to R.S. 17:1922, to be used solely for statewide planning and funding the
  32 establishment of school, community-based, and mass-media cessation and other
  33 evidence-based initiatives to prevent and control the use of all tobacco products
  34 including but not limited to cigarettes, cigars, smokeless tobacco, smoking tobacco,

1 2	vapor products, and all emerging tobacco and nicotine products by youth and young adults in schools and the community.
3 4 5 6	(2) Forty percent to the Louisiana Department of Health, Office of Public Health, Bureau of Chronic Disease Prevention and Healthcare Access, for the tobacco related disease program administered by the Well-Ahead Louisiana Program to be used solely as follows:
7 8	(a) To administer the Louisiana Quitline that provides cessation services to youth and adults across the state.
9 10	(b) To fund evidence-based prevention and cessation initiatives, outreach, and media strategies.
11 12 13	(c) To fund contracts, cooperative endeavor agreements, or other similar agreements with organizations to expand education and cessation in target communities.
14 15	(d) To fund expenses related to administering the programs provided for in Subparagraphs (a) through (c) of this Paragraph.
16 17 18 19 20 21	(3) Ten percent to the Cancer Center of Louisiana State University Health Sciences Center in Shreveport to be used solely for funding the establishment of smoking prevention mass-media programs and evidence-based tobacco control programs within the public hospital system and the screening, prevention, and treatment of tobacco use and dependance among individuals with diseases caused or exacerbated by tobacco use.
22 23 24 25 26 27	(4) Ten percent to the Mary Bird Perkins Cancer Center in Gonzales, Louisiana to be used solely for funding the establishment of smoking prevention mass media programs and evidence-based tobacco control programs within the public hospital system and for the screening, prevention, and treatment of tobacco use and dependance among individuals with diseases caused or exacerbated by tobacco use.
28 29 30 31 32 33	D. No amount appropriated as required in this Section shall displace, replace, or supplant appropriations from the state general fund for the recipients of the fund. This shall mean that no appropriation for any fiscal year from the fund shall be made for any purpose for which a general fund appropriation was made in the previous year unless the total appropriations for the fiscal year from the state general fund for such purpose exceed general fund appropriations for the previous year."
