2	To amend and reenact R.S. $37:3555(A)(11)$ and $(14)(a)$ and $3561(A)(2)(b)$ and to enact R.S.
3	37:3565(C) and 3569, relative to massage therapy; to provide relative to powers and
4	duties of the board; to provide relative to licensure and renewals; to provide for
5	criminal background checks; to provide for inspections and complaints; to provide
6	for penalties; to provide for accountability and reporting to the legislature; to provide
7	for terms, conditions, procedures, and enforcement; and to provide for related
8	matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 37:3555(A)(11) and (14)(a) and 3561(A)(2)(b) are hereby amended
11	and reenacted and R.S. 37:3565(C) and 3569 are hereby enacted to read as follows:
12	§3555. Powers and duties of the board
13	A. The board shall:

15	(11) Develop a process to review all complaints made to the board, except

8	submitted to the bureau for qualification and registry, and the bureau shall, upon

11	information contained in the bureau's criminal history record and identification files
12	that pertain to the applicant for licensure. In addition, the fingerprints shall be
13	forwarded by the bureau to the FBI for a national criminal history record check.

18	(b) The board may shall require any renewing applicant licensed prior to
19	April 1, 2022, to submit to a state and federal background check as described in R.S.

21	convicted of any sex-related crime, crime of violence, or crime related to the practice
22	of massage therapy.

26	C.(1) Any owner, manager, or supervisor of a massage therapy
27	establishment who violates the provisions of this Chapter, when the violation

9	A. The board shall submit an annual report to the legislature no later

15	(3) A summary of each complaint involving repeat offenders.
16	(4) The total number of inspections conducted during the preceding

18	unlicensed massage therapist establishments and unlicensed massage therapists
19	discovered during each inspection.
20	(5) The total number of active massage therapist licensees and massage
21	therapist establishment licenses, the number of new massage therapist and
22	massage therapist establishment licenses issued during the preceding year, the
23	total number of massage therapist and massage therapist establishment licenses
24	renewed during the preceding year, and the total number of massage therapist
25	and massage therapist establishment licenses suspended or revoked during the
26	previous year.

28	<u>at minimum:</u>
29	(1) A description of the outcome or resolution of each complaint.

2	(a) Issuance of a warning or cease and desist order.
3	(b) Imposition of a fine.
4	(c) Suspension or revocation of an individual or massage therapist
5	establishment license.
6	(d) Referral to law enforcement or another regulatory body.
7	(e) Any other action.
8	(3) Name and title of the board member or investigator assigned to
9	handle the complaint, as well as the date the complaint was filed and the date
10	investigation proceedings commenced and the final resolution date, if the
11	investigation is resolved.
12	(4) Any administrative or legal proceedings arising out of the complaint.

Present law provides for the licensure and regulation of the practice of massage therapy.

<u>Present law</u> requires the La. Board of Massage Therapy (board) to develop a process to review all complaints made to the board.

<u>Proposed law</u> retains <u>present law</u> and requires the board to conduct an unannounced, inperson inspection by the board of all complaints alleging illicit activity at a massage therapy establishment, within 10 days of receiving the complaint.

<u>Present law</u> requires the board to receive a criminal background check for any person who is licensed or is applying to be licensed with the board.

<u>Proposed law</u> retains <u>present law</u> and requires the board to receive a criminal background check for any person who is applying for a massage therapist establishment license with the board.

<u>Present law</u> allows the board to require any renewing applicants, licensed prior to April 1, 2022, to submit to a state and federal background check.

<u>Proposed law</u> requires all renewing applicants to submit to a state and federal background check.

<u>Present law</u> provides that a violation of <u>present law</u> is punishable by a fine of no more than one thousand dollars or up to six months in jail, or both. Further provides that upon conviction, the owner or operator of the massage establishment is barred from obtaining a

massage therapist or establishment license for up to five years.

<u>Proposed law</u> retains <u>present law</u> and further provides that if any owner, manager, or supervisor of a massage therapy establishment violates <u>present law</u> in connection with the operation of the massage therapy establishment, the establishment license will be revoked by the board.

<u>Proposed law</u> provides that after an establishment license is revoked, no occupational license, permit, or massage therapy establishment license shall be reissued for the same premises by either the board or a local governing authority.

<u>Proposed law</u> requires the board to submit an annual report to the legislature, no later than March 1st of each year with the following information:

- (1) The total number of complaints received.
- (2) A summary of each complaint received including the nature of the violation.
- (3) A summary of complaints involving repeat offenders.
- (4) The total number of all inspections conducted during the preceding calendar year.
- (5) The total number of active licenses of both individual massage therapist and massage therapist establishments and the number of new licenses, renewals, suspensions, and revocations.

Proposed law provides for each complaint investigated and resolved, the report shall include:

- (1) A description of the outcome or resolution.
- (2) Results of the complaint.
- (3) Name and title of the board member or investigator assigned to handle the complaint, as well as the date the complaint was filed and the date the investigation commenced and was resolved.
- (4) Any administrative or legal action arising out of a complaint.

<u>Committee Amendments Proposed by Senate Committee on Commerce, Consumer</u> <u>Protection, and International Affairs to the original bill</u>

Requires that violations by an owner, manager, or supervisor of a massage therapy establishment result in a the revocation of a massage establishment license and prohibits a new license or occupational license, permit, or massage therapy establishment license from being issued for the same location.
