Amendments proposed by Senate Committee on Education to Original Senate Bill No. 202 by Senator Harris

1 AMENDMENT NO. 1

On page 1, line 6, after "institution" delete the remainder of the line and insert a semicolon
";"

- 5 On page 3, delete lines 3 through 7 in their entirety and insert the following:

6	"C. The Board of Supervisors of Louisiana State University and
7	Agricultural and Mechanical College shall develop policies and procedures to
8	resolve issues related to the status and tenure of employees of the University of
9	New Orleans which may arise from the transfer of the institution to the
10	Louisiana State University System, and shall take necessary actions to support
11	the transition, including but not limited to:
12	(1) The formation of a transition team comprised of stakeholders from
13	the Greater New Orleans region and members of the House and Senate
14	committees on education.
15	(2) Development of a comprehensive transition plan informed by
16	external assessments of finances, academic programs, and facilities as
17	appropriate, to improve the academic, operational and fiscal performance of the
18	University of New Orleans, and present the plan to the Board of Regents and
19	the House and Senate committees on education no later than April 1, 2026."

- 20 AMENDMENT NO. 3
- 21 On page 3, between lines 22 and 23, insert the following:

"(3) Prior to receipt of such approval, continue to balance the University of New Orleans' budget in close collaboration with the Board of Supervisors of Louisiana State University and Agricultural and Mechanical College, with a view to strengthening the fiscal health of the University of New Orleans."

- 27 On page 3, at the beginning of line 23, change "(3)" to "(4)"

- 29 On page 4, line 15, after "<u>review</u>" and before "<u>and</u>" insert "<u>of the Board of Regents</u>"
- 30 <u>AMENDMENT NO. 6</u>
- 31 On page 4, delete lines 17 through 29 and insert the following:

32	"F. The commissioner of administration shall:
33	(1) Ensure that sufficient funds and resources are available to fully effect
34	the transfer of the University of New Orleans to the Louisiana State University
35	System. Such funding and resources shall not impact the Board of Regents'
36	formula for the equitable distribution of funds to institutions of postsecondary
37	education.
38	(2) Purchase available insurance for indemnification and costs which
39	may arise from the transfer; provided however, that the commissioner of
40	administration shall indemnify"

- 2 On page 5, at the beginning of line 5, delete "(2) Effective beginning with the 2025-2026
- 3 Fiscal Year" and insert "G. Upon the date of transfer"
- 4 AMENDMENT NO. 8
- 5 On page 5, line 15, at the end of the line insert the following:

6"The legislature may place reasonable conditions on the granting of7transition funding, such as the receipt of a comprehensive transition plan or8demonstration of benchmarks reached."

9 AMENDMENT NO. 9

10 On page 5, delete lines 22 through 29 in their entirety and insert the following:

"(2) The Board of Supervisors of Southern University and Agricultural and 11 12 Mechanical College, the Board of Supervisors for the University of Louisiana 13 System, and the Board of Supervisors of Community and Technical Colleges each shall adopt by not later than February 1, 2012, a written plan of action including 14 15 timelines, deadlines, requirements, and procedures for achieving the goals specified 16 in Subsection A of this Section as they relate to the powers, duties, functions, and 17 responsibilities of the boards provided by Article VIII, Section 5(E), of the Constitution of Louisiana and other applicable law. Each board also shall submit 18 19 copies of its adopted action plan to the House Committee on Education and the Senate Committee on Education. The Board of Supervisors of Louisiana State 20 21 University and Agricultural and Mechanical College's plan pursuant to 22 Subsection (C)(2) of this Section shall set a bold vision for the success of the 23 University of New Orleans and robust implementation of the plan to ensure world-class educational offerings for the Greater New Orleans region. The plan 24 25 shall address, at a minimum, strong alignment to the workforce needs of the 26 region and the state, a focus on both excellence and efficiency in the integrated 27 delivery of higher education in the region, and comprehensive stakeholder 28 engagement to ensure community support."

30 On page 6, delete lines 1 through 3 in their entirety
