HIGHWAYS. Designates certain portions of Louisiana Highways

DIGEST

Designates a portion of La. Hwy. 466 and La. Hwy. 18, in Gretna, La., Jefferson Parish as the "Chief B.H. Miller, Jr. Memorial Highway".

Designates the elevated portion of La. Hwy. 31 in Arnaudville, which crosses Bayou Fuselier as the "Coach Raymond Lavergne Sr. Memorial Bridge".

Designates a portion of La. Hwy. 26 in Jefferson Davis Parish as the "Dr. Martin Luther King Memorial Highway".

Designates a portion of North Frontage Road in Jefferson Davis Parish as "Representative John E. Guinn Memorial Highway".

Designates a portion of La. Hwy. 20 in LaFourche Parish as the "Martha Ann Woods-Shareef Highway".

Redesignates a portion of United States Highway 167 known as McMullen Street in Dubach, Louisiana, in Lincoln Parish, as the "Chief Russell Croxton Memorial Highway".

Designates a portion of Louisiana Highway 3002, in Livingston Parish, as the "Corporal Shawn Kelly Memorial Boulevard".

Designates a portion of United States Highway 190, in Covington, Louisiana, St. Tammany Parish, as the "Sergeant Linden Beau Raimer and Deputy Sheriff Marylin Mayo Memorial Highway".

Directs the Dept. of Transportation and Development (DOTD) to erect and maintain appropriate signage reflecting these designations provided local or private monies are received by DOTD equal to its actual costs for material, fabrication, mounting posts, and installation of each sign, not to exceed the sum of \$550 per sign.

- 3. Add the designation of the portion of La. Hwy. 20, at the intersection of La. Hwy. 20 and La. Hwy. 307 to the LaFourche and St. James Parish line as the "Martha Ann Woods-Shareef Highway".
- 4. Make technical changes.
