AN ACT

HIGHWAYS/INTERSTATE: Designates portions of certain Louisiana highways

2	To designate a portion of Louisiana Highway 39 in East Saint Bernard Parish as the "Lynn
3	B. Dean Memorial Highway"; to redesignate a portion of Louisiana Highway 46 in
4	Saint Bernard Parish as the "Henry Rodriguez Jr. Memorial Highway"; to designate
5	a portion of Louisiana Highway 20 in Lafourche Parish as the "Martha Ann Woods-
6	Shareef Highway"; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. The portion of Louisiana Highway 39 in East Saint Bernard Parish, from
9	Saint Bernard Parkway to the Plaquemines Parish state line, shall be known and is hereby
10	designated as the "Lynn B. Dean Memorial Highway".
11	Section 2. The portion of Louisiana Highway 46 in Saint Bernard Parish, from LA-
12	1245 to Florissant Highway shall be known and is hereby redesignated as the "Henry
13	Rodriguez Jr. Memorial Highway".
14	Section 3. The portion of Louisiana Highway 20 in Lafourche Parish, from the
15	intersection of Louisiana Highway 20 and Louisiana Highway 307 to the St. James Parish
16	line, shall be known and is hereby designated as the "Martha Ann Woods-Shareef Highway".
17	Section 4. The Department of Transportation and Development or its contractors are
18	hereby directed to erect and maintain appropriate signage reflecting these designations
19	provided local or private monies are received by the department equal to the department's
20	actual cost for material, fabrication, mounting posts, and installation of each sign, not to
21	exceed the sum of five hundred fifty dollars per sign.

Designates a portion of La. Hwy. 39 in East Saint Bernard Parish as the "Lynn B. Dean Memorial Highway".

Redesignates a portion of La. Hwy. 46 in Saint Bernard Parish as the "Henry Rodriguez Jr. Memorial Highway".

Designates a portion of La. Hwy. 20, in Lafourche Parish, from the intersection of La. Hwy. 20 and La. Hwy. 307 to the St. James Parish line, as the "Martha Ann Woods-Shareef Highway".

Directs the Dept. of Transportation and Development (DOTD) to erect and maintain appropriate signage reflecting these designations provided local or private monies are received by the DOTD equal to its actual cost for material, fabrication, mounting posts, and installation of each sign, not to exceed the sum of \$550 per sign.
