2	To amend and reenact R.S. 26:241(18), relative to manufacturers or brewers; to provide for
3	the definition of manufacturers or brewers; to provide for the sale and service of the
4	products of manufacturers or brewers; to provide for regulations; and to provide for
5	related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 26:241(18) is hereby amended and reenacted to read as follows:
8	§241. Definitions
9	The following terms have the respective meanings ascribed to them except
10	in those instances where the context indicates a different meaning:

12	(18) "Manufacturer or brewer" means any person who, directly or indirectly,
13	personally or through any agency, person, or establishment, engages in the making,
14	blending, rectifying, brewing, or other processing of alcoholic beverages in
15	Louisiana or outside the state for shipments to licensed wholesale dealers within the
16	state subject to the provisions of R.S. 26:364. A manufacturer or brewer who
17	operates a brewing facility entirely located in the state of Louisiana may sell or
18	serve <u>:</u>
19	(a) only Only those products brewed at that facility to the public only at that
20	facility for consumption on or off the premises but not for resale. The total amount
21	of such sales to the public for any given month shall not exceed ten percent of the

total amount of product brewed at that facility monthly or two hundred fifty barrels, whichever is greater. Any manufacturer or brewer who sells its products to the public pursuant to this Paragraph Subparagraph shall remit all state and parish or municipal sales and excise taxes to the proper tax collecting authority for all products sold to the public. A manufacturer or brewer who sells or serves its products to the public pursuant to this Paragraph Subparagraph, shall comply with all local zoning laws and regulations.

(b) Notwithstanding the restrictions in Subparagraph (a) of this Paragraph,

(b) Notwithstanding the restrictions in Subparagraph (a) of this Paragraph, provided that a manufacturer or brewer complies with the provisions of R.S. 26:286, manufacturers or brewers who own and operate a brewing facility entirely located in the state of Louisiana may sell or serve their finished products at retail directly to consumers at a farmer's market and similar venues defined by the commissioner pursuant to rules and regulations promulgated in accordance with the Administrative Procedure Act. The manufacturer or brewer shall give notice of its intent to sell its product to the commissioner at least five days in advance of the initial date of the farmer's market and any product sold at the market shall be offered at a price consistent with the current price in that geographical area.

**Abstract:** Authorizes manufacturers and brewers to sell their alcohol products at a farmer's market.

<u>Present law</u> provides that manufacturers and brewers may sell and serve the products that are brewed at their facility on the grounds of the facility provided they pay all state and parish sales and excise taxes and comply with all local zoning laws and regulations.

<u>Proposed law</u> retains <u>present law</u> and provides that manufacturers and brewers may sell and serve their products at a local farmer's market provided they give the commissioner of alcohol and tobacco five days advance notice before the market begins and sell the product at a price consistent with the current price in the geographical area of the market.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Judiciary</u> to the <u>original</u> bill:

- 1. Clarify that only the products brewed at the facility may be sold at the facility.
- 2. Provide that in addition to selling the products at the facility, products may be served and sold at a local farmer's market.
